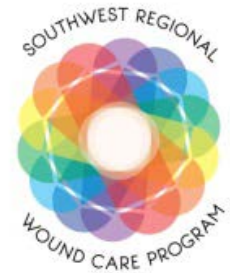

Categories to consider for both oral and poster abstract submissions include ostomy, wound, continence or leadership that are research, case study or practice based or demonstrate leadership of the ETN profession.
